This privacy policy will help you understand how the Green Learning Homestead uses and protects the data you provide to GLH when you visit and use the GLH website.

Comments

When visitors leave comments through the GLH website, GLH collects the data shown in the comments form and also the visitor's IP address and browser user agent string to help with spam detection. Visitor comments may be checked through an automated spam detection service.

Verification – An anonymized string created from your email address (also called a hash) may be provided to the Gravatar service to see if you are using your email or to detect if it's been hacked. The Gravatar service policy is available here: <https://automattic.com/privacy/>. After approval of your comment, any profile photo attached to your email may become visible to the public within the context of your comment.

Media

Your Location – It may be possible for visitors to the GLH website to download and extract location data from images on the GLH website. If you upload images to the GLH website, such as through the Forum, you should avoid uploading those with embedded location data (EXIF GPS).

Information Collected

The only information collected by GLH is your name, your address (for sales tax), and your email address. No other information is relevant.

How Data is Collected

This information is collected only when you provide it, generally during the purchase process, when submitting material for review through the Forum, or when contacting us via email.

Purpose of Data Collection

Your name and email address are required to provide you with the information you purchase or to respond to you via email through the forum or through your email submission. This also establishes your GLH account. Your name and email request are also required to maintain your participation in the subscription service, provide you with acknowledgement of your purchase, and to provide you with a payment receipt.

Data Sharing Practices

Your name, address, and email address will not be shared to anyone for any purpose.

User Control Over Data

Your data will be deleted from the Green Learning Homestead data files upon your request.



Safeguarding and Securing Your Data

Green Learning Homestead is committed to securing your data and keeping it confidential. Green Learning Homestead has done all in its power to prevent data theft, unauthorized access, and disclosure by implementing the latest technologies and software, which help us safeguard all the data we collect online.

Green Learning Homestead will not lease, sell, or distribute your personal information to any third parties, unless we have your permission. GLH might do so if the law forces us. Your personal information will only be used when GLH needs to send you materials you have purchased or to announce availability of updates to materials you have purchased.

Cookie Policy

GLH only uses cookies as needed within the Green Learning Homestead website. GLH does not allow cookies to escape to the web for any sort of third-party advertising.

Links to Other Websites

The GLH website may contain links to other websites. If you visit these links through the GLH website, Green Learning Homestead is not held responsible for your data and privacy protection. Visiting these websites is not governed by this privacy policy. Make sure you read the privacy policy documentation of any website you go to away from the GLH website.

GLH Member Number

You may request a reset of your GLH member number at any time. If you request a reset, your IP address will be included in the reset email.

Management of Your Personal Data

At some point you may wish to restrict the collection and use of your personal data. You can achieve this by contacting GLH via the email form in the Contact Us section and GLH will change this for you.

If you leave a comment, the comment and its metadata are retained indefinitely so GLH can recognize and approve any follow-up comments automatically instead of holding them in a moderation queue.

For users that register in the GLH website, GLH anonymously stores profile information only without any identifying information such as name and email. This is to identify interests of those engaging with GLH.

User Name and Password

These exist solely to provide you with access to your purchase history and to change personal information restricted to name and email. No financial information will be revealed such as credit card numbers.
